of Mecklenburg and State of Kentucky being weak in body
and being also in my perfect Mind & Memory but calling to
mind the Mortality of my body and knowing and believing that
It is Once appointed for all men to die I have thought
proper while in my perfect mind to make this my last
Will and testament In the first place I will my soul to God in
who gave it and In the second place I will that my administrator
pay my funeral expences and all just debts that
I may owe at my death Thirdly it is my desire that my
Wife Sarah Jones have my house and farm also the household
furniture Kitchen furniture together with my Negroe girl
Mandy during her life and after her death it is my will that
all my estate personal and real to be equally divided among
all of my children Fourthly it is my will provided my wife
Sarah Jones and my Son John R Jones can make arra-
gements among them selves for my son John to take charge
of the farm Stock house hold & Kitchen furniture and for
my son John to give his obligation to his mother for her main-
tenance and at my wifes death it is my will that my son
John have all my perishable property over and above an
equal division of the rest other property and in case my
Wife and my Son John R Jones cannot make the arrangements
designed in this my last will and testament Then my
Wife Sarah Jones is to remain on the farm and keep my
property off a perishable nature and the Negroe girl during
her childhood and this is not to run my estate in debt
and this is to consist with my Son Richard Jones who
I leave as my sole Administrator and in case my wife
Sarah Jones should be unable to manage the farm & take
care of herself then in that case it is my will that my
son Richard Jones take charge of my estate both real
and personal and make arrangements to have my wife
Sarah Jones taken care of during her lifetime it is clearly
understood that my son Richard is to comply with this
my last request, only in case my wife Sarah Jones
cannot make the arrangements requested in this my will
Lastly I do hereby constitute and appoint my son Richard
Jones my Administrator of this my last will and testament
hereby revoking all other wills by me made heretofore

hand and Seal this 22 day of Sept 1861

Panhandle County Court (Day 29 1855)

A paper purporting to be the last will and testament of Peter Jones was produced into Court and proved to be the act and deed of said decedent by James W. Daag one of the subscribers witnesses to the same and continued into the next term of this Court - Muhlenberg County, County - Term Called Court April 5¹⁸⁵⁵. The will of Peter Jones deceased was again presented into Court and Taylor R. Clark one of the subscribers being sworn upon his oath proved the same to be the act and deed of said decedent wherupon said will was ordered to be recorded - which with this certificate hath been truly recorded
