I, John Gray, a resident of Central City, Muhlenberg County, Kentucky, being of sound mind, memory and understanding, and of testamentary capacity do make this my Last Will and TesTament hereby revoking all former wills made by me.

I desire that all my just debts, funeral expenses, and doctor bills be paid as soon after my death as practicable, however it is not my desire that any part of my estate, real, personal or otherwise be sagrificed in order to pay these bills and expenses.

SECOND. . I will and bequeath unto each one uf my children who are living the sum of One Dollar this to be their entire interest in my estate; I also leave unto each heir of a child or children who may now be dead or may die before I should, the sum of One Dollar, this to be their entire interest in any and all of my estate.

THIRD. .I will and bequeath unto my beloved wife all of my estate, whether, real, personal or otherwise of which I may die possessed, e ach and all of this estate to be hers absolutely to do with as she pleases, to sell, to mortgage, or to dispose of in any way she may see proper, in fact to enter into possession of all of said property whether real or personal the same as I now own it, and any deed or mor tgage The money in signed by her shall be as perfect as though signed by me in person. bank shall become the property of my wife immediately after my death, and shall be hers the same as it is now mine. I leave all of my property to my wife, Maria Gray, for the reason that had it not been for her work and economy I would have nothing on which to now live much less to leave to her after my death so that the property which I now hold is really the property of my wife and I desire that she shall enter into its possession as soun after my death as possible and enjoy all of its benefits the same as I do now.

FOURTH. I hereby appoint and make my said wife, Maria Gray, Executrix of this my Last Will and Testament , she to act without giving bond as I desire that all of my estate shall go to her with as little expense as possible. Neither shall there be an inventory made of my estate, but the entire estate, just as it is both personal and real to be turned over to my beloved and devoted wife Maria Gray.
