In this 2nd day of October 1864
before me the undersigned
one of the Circuit Judges for
the District of Franklin and
State of Kentucky Jos. Garvey
a Minister of Gallatin County
and State of Kentucky
fifty eight years and made
the following Declaration
on oath he in order to ob-
tain a Pension under the
Act of Congress passed the
11th of March 1864 for the
"Officers & Privates engaged
in the Land & Naval Service
during the Revolution"
Jos. Garvey that he was
Enlisted in Westmoreland Co. Va.
Virginia about the year 1777
under Capt Richard Barnette
in the 5th Virginia Regiment.

for two years and then re-enlisted
under Capt. Hargraves for
three years in the 4th
Regiment of Artillery and was disch-
arged in 1782 at Frederick-
burgh Virginia by Col. Hargraves and then afterwards
re-enlisted for eighteen months
under Capt. Warran making
his whole service five years
as a Regular Soldier
in the Revolution & Egyptian
wars as a private making
his whole service five years
and a half. He further
states that he was in the
Battle of Monmouth at
the taking of the Fort called
"Douglas Hook" near New York
in the Siege of "Charleston"

and at the bridge of York
and then in a Memorandum
sent by the way
of the "Indians" near
Savannah Georgia
that he is old and infirm
and now in reduced cir-
-cumstances in life and
stands in need of the
assistance of his country
and that he has received no pension
for his support and therefore he
is destitute and further that
he has evidence now in his hands
of his services besides
the officer's of West Abraham
Dan have annexed
to the under my hand the
copy of year just above
written

Declaration
I do hereby declare the benefit of an Act of
Congress of the 7th July 1838 entitled an Act Grant-
ing help pay and pensions to certain Widows
of the County of Boone.

On this day personally app-
eared before me the undersigned a Justice of
the peace and for the County aforesaid
Elizabeth Gervy a resident of the County of
Boone State of Kentucky aged 72 years who
being first duly sworn according to Law doth
then and there make the following Declaration
in order to obtain the benefit of the Provisions
made by the act of Congress passed July 7th
1838 entitled an Act Granting help pay and
Pensions to certain Widows that she is the Widow
of Lot Gervy who was a Private Soldier on
the Virginia Line during the war of the
Revolution and was placed on the Pension
roll in Gallatin County Kentucky under
the Law of Congress March the 18th 1818 and was
in a short time stricken from the Pension
Roll in consequence of his possessing two much
Property and she refers to the papers on file
for evidence of his service she was married
as she further declares to the said Lot
Gervy in Richmond County Virginia to
on the seventh day of ~~January~~ ^{February} ~~seventeen~~ hundred
and Eighty One and her husband aforesaid
Lot Gervy died on the twentieth day of
January 1827 and she was not married to
him prior to his leaving the service but
the marriage took place previous to the first
of January seventeen hundred and ninety four
(1894) at the time above stated and she has rem-
ained a widow ever since the death of her
husband the said Lot Gervy as will more
fully appear by reference to the proof hereto
attached and she presents her Family Record

Dear Madam:

Reference is made to your request for the Revolutionary War record of Job Garvey.

The data furnished herein were obtained from papers on file in the pension claim, W. 8839, based upon the military service of Job Garvey, the only soldier by that name that is found in the Revolutionary War records of this office.

Job Garvey enlisted in Westmoreland County, Virginia, about 1777, served as private in Captains Richard Barnett's and Henry Fountleroy's Virginia companies; was in the battles of Monmouth, Paulus Hook, in the siege of Charleston and the siege of Fort Mifflin and was in a skirmish with the Indians near Savannah, Georgia, under General Anthony Wayne and was discharged in 1782. He later enlisted and served eighteen months in Captain Warman's Virginia company.

He was allowed pension on his application executed October 26, 1818, while a resident of Gallatin County, Kentucky, then aged fifty-eight years.

He died January 20, 1827.

This soldier married February 7, 1781, in Richmond County, Virginia, Elisabeth, her maiden name not given.

She was allowed pension on her application executed September 13, 1838, while a resident of Owen County, Kentucky, at which time she was seventy-two years of age.

One Jeremiah Garvey was justice of peace in Owen County, Kentucky, in 1838, no relationship stated.
