My grandparents Martha Ann Mockbee Allender and grandfather Wiley Ellis were never married but had three children. Martha Ann(a) took Wiley to court sometime in the period 1916-1918 -the children were given the name Ellis and Wiley paid \$5,000 for their upkeep. Martha -listed herself as Anna Ellis (divorced) in the 1920 census along with her three children, Anna Mabel, Marjorie May and Wiley Eugene (my father). Can anyone help me find specifics about that court action? My father was the youngest child born in 1913, Martha Mockbee granddaughter of Sarah Ellis was originally married to Newell Allender. Martha and Newell had one son Othel. The court records could say Martha Allender vs Wiley Ellis . My father's birth certificate originally said Wiley Eugene Allender but was changed to Ellis.
